| <p><u>Site of Care Redirection Program for Infusions</u></p> <p><u>(a) Effective July 1, 2023, the Empire plan will implement a Site of Care (SOC) Redirection Program for infusions. Drugs used to treat cancer and hemophilia are excluded from this program. This program will apply to Empire Plan primary members only.</u></p> <p><u>(b) The Site of Care Redirection Program for Infusions shall be administered pursuant to the Site of Care Redirection Program for Infusions sideletter. The Joint Committee will meet regularly to discuss the rollout of the program and jointly oversee the implementation and administration of the program, including how access to care and medical concerns will be addressed.</u></p> <p><u>(c) Upon implementation, the medical or prescription drug copayments associated with infusions under the Site of Care Redirection Program will be waived when the enrollee uses a non-hospital infusion site of care.</u></p> |
